Persons interested in purchasing must personally attend the designated place where the sale will take place to select the residential property that the person wishes to purchase. The Vendor does not accept any person having queued up at the place where the sale will take place before the Time of the Sale on the date concerned.	
If there are 2 or more parties interested in purchasing the same residential property(ies) at the commencement time on any day of sale, balloting will be conducted to determine the order of priority of property selection.	
In case of any dispute, the Vendor reserves its absolute right to allocate the above residential property(ies) to any person interested in purchasing by any method (including balloting).	
Persons interested in purchasing the specified residential property(ies) are invited and advised to view the specified residential property(ies) of the Development before selecting the specified residential property(ies) he/she/they wish(es) to purchase. The specified residential property(ies) of the Development are available for viewing by taking prior appointment with the Vendor. Persons who have successfully selected the specified residential property(ies) shall confirm in writing that he/she/they has/have either viewed the specified residential property(ies) or the comparable residential property(ies) of the specified residential property(ies) or waived the right to view the specified residential property(ies) prior to the signing of the Preliminary Agreement for Sale and Purchase.	
Please note that the Vendor is not in a position to reserve any specified residential property(ies) for any interested persons prior to the signing of the Preliminary Agreement for Sale and Purchase.	
In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential
